

Terms of Service

Below are the terms of service for CCB REVIEW. Please select read more to read the terms of service.

1. ACCEPTANCE OF TERMS Thank you for using CCB Review's innovative platform for consumers and businesses seeking to establish mutually beneficial business relationships. CCB Review provides the CCB Review service to you, subject to acceptance without modification of all of the terms and conditions contained herein and all other operating rules, policies and procedures that may be published from time to time on this site by CCB Review (collectively the "Terms"). We reserve the right to modify these terms by posting a notice on our website, or by sending you a notice via email or postal mail. You shall be responsible for reviewing and becoming familiar with any such modifications. Such modifications are effective immediately upon first posting or notification, and use of our website or any services by you following such posting or notification constitutes your acceptance of these Terms as modified. **IF YOU DO NOT AGREE TO ALL OF THESE TERMS, THEN DO NOT ACCESS OR USE THE SERVICE.
